

# TEXAS HISTORIC TAX CREDIT PROGRAM

The Texas Historic Preservation Tax Credit (THPTC) program seeks to evoke the past in building Texas' future, creating opportunities for business and tourism while preserving culture and identity, increasing property values, connecting communities, and ultimately, creating a thriving local economy.

Historic tax credits are important to protecting and revitalizing communities and providing renovated facilities for culture, commerce, and entertainment. The Texas Legislature created the 25% THPTC in 2013 to increase historic preservation projects across the state. The THPTC is based on the Federal Rehabilitation Tax Credit program, which provides a credit for federal income taxes equal to 20% of qualified expenses. Half of all state projects also apply for the federal program, receiving a total of 45% in eligible credits.

To date, this historic tax credit program has resulted in more than 500 Texas applications in 45 cities across the state. Of these, 243 projects were completed by the end of 2020, representing an investment over time of \$1.8 billion in qualifying rehabilitation expenses. These projects represent places of worship, hotels, industrial buildings, cultural nonprofits, historic downtowns, universities, and private residences (Texas Historical Commission, Report on Historic Preservation Tax Credits in Texas, 2020).

#### UNDERSTANDING HISTORIC TAX CREDITS

#### What is a tax credit?

A tax credit is a direct reduction in the amount you have to pay for taxes in a given year. For example, if you owe \$10,000 in taxes and you have a \$2,000 credit, you'll only need to pay \$8,000. The tax credit is awarded upon completion of the rehabilitation project.

#### How can I rehabilitate my property to receive the credit?

Properties must meet several criteria to be eligible for the THPTC:

- 1. Must be historically significant enough to be listed in the NRHP.
- 2. Must be either:
  - · Income-producing (commercial, industrial, or rental-residential)
  - Owned by a non-profit, not-governmental agency
- All work must meet the Secretary of the Interior's Standards for Rehabilitation, a list of 10 guidelines that must be considered when planning the project.

## What are some examples of repairs and rehabilitation that qualify for the THPTC program?

Generally, the rehabilitation or repairs need to affect structure or architectural features of your historic building. Qualified repairs include the following:

- · Historic windows
- · Structural (including roofs and foundations)
- · Plumbing, electrical, and mechanical systems
- · HVAC and heating systems
- Life safety and ADA compliance (sprinkler systems, fire doors, ramps, and elevators)
- · Professional fees (architects, engineers, and consultants)
- · Solar panels, wind turbines, and geothermal systems

### **PROJECT PROFILES**

### 1. ST. PAUL'S UNITED METHODIST CHURCHHouston, Texas2022 GOOD BRICK AWARD WINNER

St. Paul's United Methodist Church applied for the THPTC as part of their planned \$12 million renovation of their 1930s Gothic Revival building. SWCA prepared their NRHP nomination, worked with the project architect to confirm all work complied with rehabilitation standards, reviewed drawings, and advised the project committee about the tax credit process. **Tax credits earned: \$2.3 Million.** 



### 2. THE BRYAN MUSEUM Galveston, Texas

The Bryan Museum houses one of the world's largest collections of historical artifacts, documents, and artwork relating to Texas and the American West. Located in the historic Galveston Orphans Home in Galveston, Texas, historic restoration work was completed in late 2015. SWCA supported the preparation and development of a THPTC application. **Tax credits earned: \$1.1 Million.** 



### 3. W-K-M HISTORIC DISTRICT Houston, Texas 2020 GOOD BRICK AWARD WINNER

SWCA prepared THPTC applications to recoup costs for three different buildings in the district related to almost \$800,000 in interior renovations, ADA upgrades, roof replacements, and life safety requirements. **Tax credits earned: \$195,660.**
